The PIO while rejecting the request shall communicate to the person making the request:

- The reasons for such rejection;
- The period within which an appeal against such rejection may be preferred; and
- The particulars of the appellate authority.

4. PROCEDURE FOR MAKING REQUESTS

- Apply in writing or through electronic means in English or Hindi or Punjabi to the PIO or APIO, specifying the particulars of the information sought for.

Pay Rs. 10/- (Ten) as application fee by way of cash against proper receipt or by demand draft or banker's cheque payable to the Accounts Officer of BBMB.

- Applicant can seek review of the decision on fees charged by the PIO by applying to the appropriate Appellate Authority;
 - No fees will be charged from people living below the poverty line.
- Indicate the postal address/ contact number where PIO can send the information/ rough cost estimate (if involved) or any other query relevant to the case.
 - In case the citizen is handicapped or sensorily disabled, PIO shall provide assistance to enable access to the information, including providing assistance as may be appropriate for inspection.

5. FEE & COST STRUCTURE

- Application fees: Rs. 10/- in respect of information under Sub-Section (1) of Section 6.

a) Information under Sub-Section (1) of Section -7

- Rs. 2/- for each page (in A-4 or A-3 size paper) created or copied;
- actual charges or cost price of a copy in larger size paper;
- actual cost or price for samples or models; and
- for inspection or records, no fee for the first hour; and a fee of rupees five for each fifteen minutes (or fraction thereof) thereafter.

b) Information under Sub Section (5) of Section 7

- for information provided in diskette or floppy, Rupees Fifty per diskette or floppy;
- for information provided in printed form at the price fixed for such publication or rupees two per page of photocopy for extracts from the publication.
