

The rate of family pension in respect to employees who die in harness, during the first ten years from the date of death or till the Government employee would have attained the age of superannuation had he survived, whichever period is less, shall be as follows:

2. The rate of family pension in respect of birmlovees who die in harness, after first ten years from the date of death or till the Government employee would have avained the age of superannuation had he survived, whichever period is less, shall be as follows:-
