It is prohibited to construct the House and Plantation of trees under & adjacent to the above lines as per Indian Electricity Act, 1910(Rule-18 Sub Rule-3) read with Rule No. 82 of the India Electricity Rules, 1956. The inadequate clearance can interrupt the Transmission of Electricity and create hurdle for the Mtc. of Lines. There is danger to person and property of the owner of building/ plants. If any one violates the rule and construct the building/plants the trees adjacent/beneath the line then action will be taken against him as per Indian Electricity Act and he will be fully responsible for any kind of loss/damage to B.S.M.B. or any third party.
