

It is informed to General public that the following high voltage transmission lines are running over the below mentioned locations.

1.	33 KV Abadgarh (Mirthal) to Sansarpur Terrace (HP) Line.	ABADGARH, MIRTHAL, MILWAN, MANSAR, CHHANNI, CHANOR, SHIVO CHECK, BADIAL, KHUNDPUR, PANKHUH, BARIOWAL, KULIAN, KHUNDA, GURUDWARA GARA SAHIB, HAZIPUR, GERA, CHAKKRIAL, LALOTE, JHIR DA KHUH, NAMOLI, BHATOLI, GAWAL CHAK SINGARU, CHODRIDA BAGH, BHODE DA KHUH, SHRI PANDIAN, RAM NANGAL, DOHAR, BHERA, SANDPUR-I, SANDPUR-II, TALWARA, HALER, NAGAR, RAJWAL, SANSARPUR TERRACE (HP) ETC.
2.	11 KV Pong Switch Yard to Sansarpur Terrace (HP) double circuit line.	PONG, GAMROOR, BABA GHATI, BARNALI, SANSARPUR TERRACE ETC.
3.	11 KV Talwara -I and Talwara -II circuit line Sansarpur Terrace to 66 KV sub-station sec-4 Talwara.	SANSARPUR TERRACE, RAJWAL, HALER, NAGAR, TALWARA, SANDPUR-I, SANDPUR-II, BHERA, DOHAR, RAM NANGAL, OLD TALWARA, SUBASH NAGAR AND BBMB COLONY ETC.

It is prohibited to construct the House/Buildings and plantation of trees under and adjacent the above said lines as per Indian Electricity Act 1910 (Rule No. 18 sub Rule No.3) read with Rule No. 80 sub Rule (1 b,2 c) and 82 A of Indian Electricity Rule 1956. The inadequate clearance can interrupt the transmission of electricity and create hurdle for maintenance of lines. There is danger of person and property of the owner of Buildings, Plants. If any violate the rule and construct the Buildings/Plants the trees adjacent beneath the lines. The action will be taken against him as per Indian Electricity Act and he will be fully responsible for any kind of loss /damage to BBMB or any third party.
